Challenge Form

If a student disagrees with a Student Rights and Responsibilities decision that does not impact their academic status and the concern did not require an escalated resolution, they can submit their reasons to challenge in writing to the Associate Vice President (VP) of Student Affairs. Challenges will be considered if they meet the appropriate grounds: Personal Bias/Unfair Treatment or New Information/ Extenuating Circumstances.

The AVP or designate will review the challenge for validity and will respond within five (5) business days directly to the student in writing with appropriate steps to rectify the situation. A meeting may be arranged to discuss possible outcomes. If the challenge is denied, a reason will be provided and the previous outcome still applies. The decision of the AVP is final.
